

Directions from the 134 Freeway East to Law Office of Jami K. Fosgate:

Exit off the 134 Freeway East at PASS AVENUE. At the end of the off-ramp, turn right. Go past the stoplight at Alameda Avenue and then turn left on Riverside Drive. Riverside Drive will wind around and you will drive past the stoplight at Hollywood Way. The next stoplight is Olive Avenue and on the corner is a 15-story brick building with McCormick & Schmick's and City National Bank on the ground floor. The Law Office of Jami K. Fosgate is located on the third floor of this building. Parking is available underneath the building at a cost of about \$5.00 per hour. We do not validate parking.

Directions from the 134 Freeway West to the Law Office of Jami K. Fosgate:

Exit off the 134 Freeway West at HOLLYWOOD WAY. At the end of the off ramp, turn right onto Alameda Avenue and then turn right again at the next cross-street called Avon Street. The next stop sign is Olive Avenue and you will turn right again. The next stoplight is at Olive Avenue and Riverside Drive and on the corner to the left you will see a 15-story brick building with McCormick & Schmick's and City National Bank on the ground floor. The Law Office of Jami K. Fosgate is located on the third floor of this building. Parking is available underneath the building at a cost of about \$5.00 per hour. We do not validate parking.

Directions from the 5 Freeway North to the Law Office of Jami K. Fosgate:

TRANSITION from the 5 Freeway North to the 134 Freeway West. Exit off the 134 Freeway West at HOLLYWOOD WAY. At the end of the off ramp, turn right onto Alameda Avenue and then turn right again at the next cross-street called Avon Street. The next stop sign is Olive Avenue and you will turn right again. The next stoplight is at Olive Avenue and Riverside Drive and on the corner to the left you will see a 15-story brick building with McCormick & Schmick's and City National Bank on the ground floor. The Law Office of Jami K. Fosgate is located on the third floor of this building. Parking is available underneath the building at a cost of about \$5.00 per hour. We do not validate parking.

Directions from the 5 Freeway South to the Law Office of Jami K. Fosgate:

Exit at HOLLYWOOD WAY. At the end of the off-ramp, turn right onto Hollywood Way. Travel about 4 miles, past Victory Boulevard, past Burbank Boulevard, past Magnolia Boulevard and past Alameda Avenue. The next stoplight is Riverside Drive and you will turn left. The next stoplight is Olive Avenue and on the corner is a 15-story brick building with McCormick & Schmick's and City National Bank on the ground floor. The Law Office of Jami K. Fosgate is located on the third floor of this building. Parking is available underneath the building at a cost of about \$5.00 per hour. We do not validate parking.
